IT is the opinion of the Council that the development hereby restricted would constitute a threat to the amenities of this area and that this is therefore a Direction to which Article 4 (3)(b) applies and the Direction will therefore remain in force for six months from the date hereof and shall then expire unless it has before the termination of the said six months been approved by the Secretary of State.

NOW THEREFORE the Council in exercise of their powers under Article 4 of the Order hereby directs that the permission granted by Article 3 of the Order shall not apply to any development specified in Schedule 1 hereto upon the land and properties specified in Schedule 2 hereto.
