- (i) In the case of a headstone, footstone or kerbstone has a vase incorporated, then the separate fee for a vase shall not apply.

MISCELLANEOUS CHARGE

4.1 Searches of Burial Registers:

copy of each entry in Burial Register where death occurred more than five years before search 24 plus VAT

4.2 Memorial Seat with plaque (subject to availability):

up to 90 letters 903 plus VAT
additional plaque (only) 152 plus VAT

4.7 Memorial Tree with plaque (subject to availability):

up to 80 letters 254 plus VAT

HISTORICAL NOTES

In respect of the Fees and Charges set out under INTERMENTS and - EXCLUSIVE RIGHTS OF BURIAL, it will be noted that there exists a principle of charging non-residents exactly DOUBLE that of residents. This is a long standing policy of the Council, reflecting the differing Council Tax charge demands borne by the respective Council Tax payers within the Charnwood Borough Council area.

For instance, expenditure in respect of the upkeep of Loughborough Cemetery is, by way of a special charge, borne exclusively by Loughborough Council Tax payers whereas expenditure in respect of any Parish Council controlled cemetery within the Charnwood Borough Council area is borne exclusively by the Council Tax payers within the respective Parish Council.

Instances where the deceased has been resident in a nursing home for a year Or less they will be charged single fees. However proof of residency may be requested.
