The Development Control Service is responsible for controlling new building and changes in the use of existing buildings and land through deciding planning applications. These are decided on the basis of national planning policy and the statutory Development Plan, augmented by Supplementary Planning Documents on specific topics and other approved standards for matters such as highway design and parking. The service provides advice as to the need for planning permission and guidance on the factors that will be taken into consideration in influencing the outcome of planning applications.
