- The contract extension has been agreed and signed. The refuse vehicles have been ordered, with the sweepers to be ordered next, followed by the tippers and vans
- The Garden Waste income is on target for the year.
- Cabinet has approved the introduction of bulky waste charges from 7th October. Implementation is underway. MB to draft the criteria for exceptional hardship cases and send the to LHD for consideration.
- Trade Waste collections started in Nov 18 and the service now has over 50 customers.

MANAGEMENT OF OPEN SPACES

• A report was presented on October's Cabinet meeting regarding the proposal for a new cemetery site in Loughborough. The agricultural land at Nanpantan was agreed to be the preferred site and further survey work is being scheduled. The pre-application was submitted late Feb and the full planning application is expected to be in by August 2019.

- Work in progress look at increasing the number of Local Nature Reserves and Green Flag sites (New site for 18/19: Booth Wood). The Outwoods has lost its Green Flag due to the contents of the Management Plan. MB is asking the committee to consider making it a Local Nature Reserve instead.
- Direct access to Lagan is now in place and is closely monitored.
