This includes any person or organisation, including your political party or agent, who made a financial contribution to your election campaign, for example in printing leaflets and posters, or who assists you with the costs of carrying out your duties.

You must also include people or bodies who provide premises that relate to your official

duties, such as somewhere to hold a ward surgery, at a reduced rate or other similar payments in kind.

You do not need to declare the amounts of any payments, only the name of the person or body making them. You do not need to include payments made by the Borough Council or any other local authority.
