- Contracts Any contract which is made between me or any relevant person (or a body in which I or any relevant person has a beneficial interest) and the Council:
  - (a) under which goods or services are to be provided or works are to be executed; and
  - (b) which has not been fully discharged

You must register all current or prospective contracts, of which you are aware, between you or your partner, or a company of which you or your partner are a director or partner, or in which you know you or your partner have a substantial beneficial interest and the Council. Which you should state the nature and length of the contract, but not its value or its terms. You must register the names of any companies, industrial and provident societies, cooperative societies, building societies, public corporations, insurance companies or other corporate bodies that (to your knowledge) have land or a place of business within Charnwood and in which you or your partner have a substantial beneficial interest as defined above. If in doubt, consult your financial advisor.

You do not need to show the extent of the interest.

A beneficial interest in a type of share exists if you own it or if it is held in the name of another person, e.g. a relative or partner, and you are entitled to the proceeds of, or if you will become entitled to the proceeds of, that type of share.
