**2. Sponsorship - Any payment or provision of any other financial benefit (other than from the Borough Council) made or provided to me in respect of any expenses incurred by me in carrying out duties as a member, or towards my election expenses, including any payment or financial benefit from a trade union**

This includes any person or organisation, including your political party or agent, who made a financial contribution to your election campaign, for example in printing leaflets and posters, or who assists you with the costs of carrying out your duties.

You must also include people or bodies who provide premises that relate to your official duties, such as somewhere to hold a ward surgery, at a reduced rate or other similar payments in kind.

You do not need to declare the amounts of any payments, only the name of the person or body making them. You do not need to include payments made by the Borough Council or any other local authority.

**3. Contracts - Any contract which is made between me or any relevant person (or a body in which I or any relevant person has a beneficial interest) and the Council:**

- (a) under which goods or services are to be provided or works are to be executed; and**
- (b) which has not been fully discharged**

You must register all current or prospective contracts, of which you are aware, between you or your partner, or a company of which you or your partner are a director or partner, or in which you know you or your partner have a substantial beneficial interest and the Council. You should state the nature and length of the contract, but not its value or its terms. This could include a contract between your or your partner's employer and the Council or a contract between the Council and one of your or your partner's corporate interests (see 7 below) for the provision of goods or services where you or your partner would share in the proceeds from the contract.

**4. Land - Any beneficial interest in land which is within the Council's area**

You must register any land (including any buildings or parts of buildings) in Charnwood in which you or your partner have a beneficial interest. You should give the address or a brief description which would enable someone to identify where it is (e.g. owner of land to the north of Small Lane, opposite junction with Large Road). This could include business premises if you have a beneficial interest (e.g. if you or your partner own or lease the business property either alone or jointly).

**If you live in the Borough you should include your home under this heading whether you are the owner, lessee or tenant. This includes joint owners, lessees or tenants. Council tenancies should be registered under 6 below.**

You should also include any property from which you receive rent, or of which you are a mortgagee. You will also have a beneficial interest in any land if it is held in the name of another person, e.g. a relative, and you are entitled to the proceeds of, or if you will become entitled to the proceeds of that land.

**5. Licences (alone or jointly with others) - Any licence (alone or jointly with others) to occupy land in the Council's area for a month or longer.**

You must register land (including buildings or parts of buildings) in Charnwood which you or your partner have a right to occupy for a month or longer, but where you or they neither own nor have a tenancy of it. You should give the address or a brief description to identify it.

**6. Corporate Tenancies - Any tenancy where:  
(a) the landlord is the Council; and  
(b) the tenant is a body in which I or a relevant person has a beneficial interest**

You must register any tenancies which you, or your partner or one of your or your partner's corporate interests (see 7 below) have where the Council is the landlord. This would include a tenancy for a home which is owned by the Council, or the tenant is a body in which you or a relevant person has a beneficial interest.

7. **Securities - Any beneficial interest in securities of a body where:**  
**(a) that body has a place of business or land in the Council's area; and**  
**(b) either:**  
**(i) the total nominal value of the securities exceeds £25,000 or one hundredth of the total issued share capital of that body; or**  
**(ii) if the share capital of that body is of more than one class, the total nominal value of the shares of any one class in which the relevant person has a beneficial interest exceeds one hundredth of the total issued share capital of that class**

You must register the names of any companies, industrial and provident societies, co-operative societies, building societies, public corporations, insurance companies or other corporate bodies that (to your knowledge) have land or a place of business within Charnwood and in which you or your partner have a substantial beneficial interest as defined above. If in doubt, consult your financial advisor.

You do not need to show the extent of the interest.

A beneficial interest in a type of share exists if you own it or if it is held in the name of another person, e.g. a relative or partner, and you are entitled to the proceeds of, or if you will become entitled to the proceeds of, that type of share.
