**2. This includes any person or organisation, including your political party or agent, who made a financial contribution to your election campaign, for example in printing leaflets and posters, or who assists you with the costs of carrying out your duties.

You must also include people or bodies who provide premises that relate to your official duties, such as somewhere to hold a ward surgery, at a reduced rate or other similar payments in kind.

You do not need to declare the amounts of any payments, only the name of the person or body making them. You do not need to include payments made by the Borough Council or any other local authority.

**3. Contracts - Any contract which is made between me or any relevant person (or a body in which I or any relevant person has a beneficial interest) and the Council:**

- (a) under which goods or services are to be provided or works are to be executed; and**
- (b) which has not been fully discharged**

You do not need to show the extent of the interest.

A beneficial interest in a type of share exists if you own it or if it is held in the name of another person, e.g. a relative or partner, and you are entitled to the proceeds of, or if you will become entitled to the proceeds of, that type of share.
