

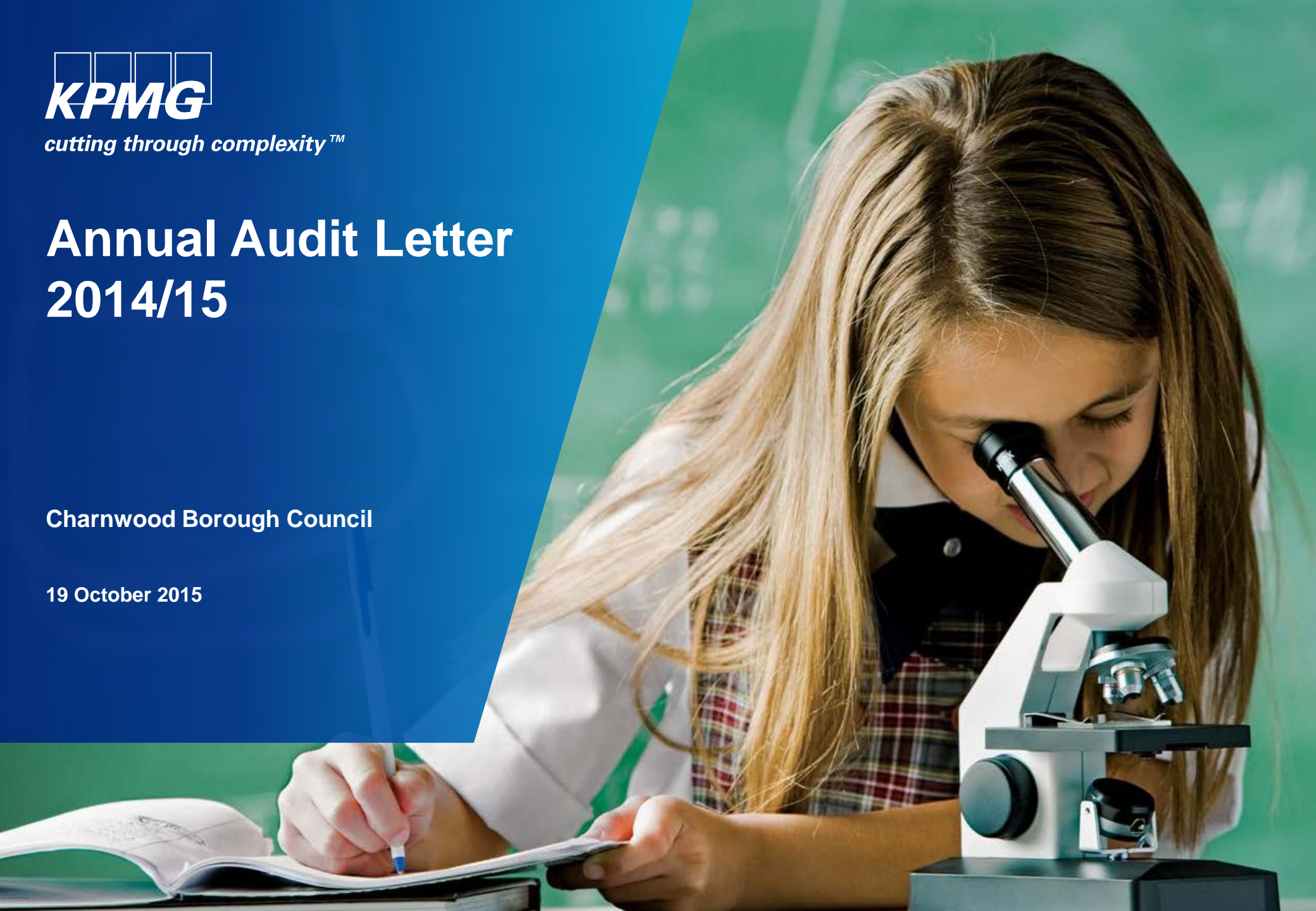

This report summarises the key findings from our 2014/15 audit of Charnwood Borough Council (the Authority).

Although this letter is addressed to the Members of the Authority, it is also intended to communicate these issues to key external stakeholders, including members of the public.

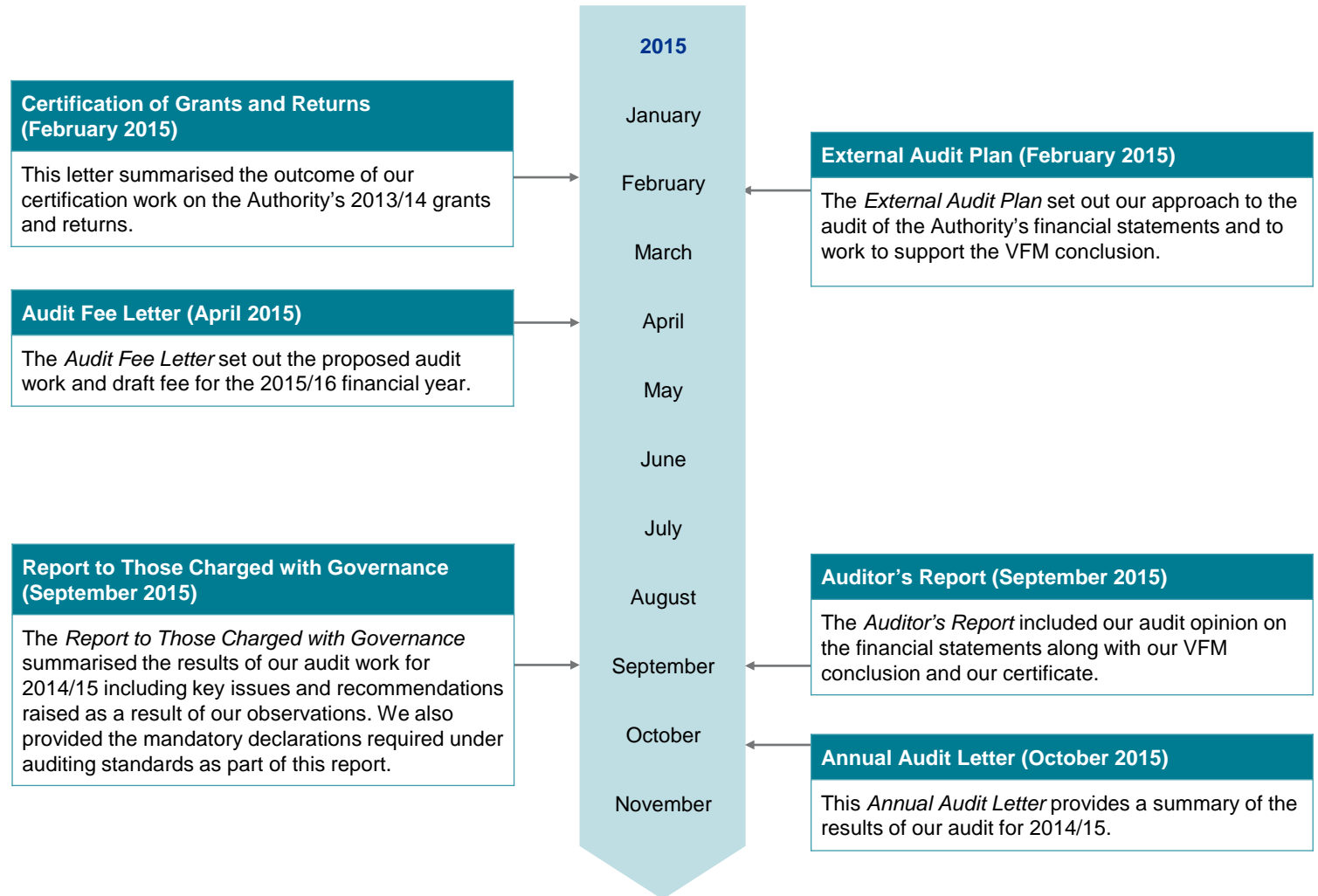
Our audit covers the audit of the Authority's 2014/15 financial statements and the 2014/15 VFM conclusion.

All the issues in this Annual Audit Letter have been previously reported. The detailed findings are contained in the reports we have listed in Appendix 1.

VFM conclusion	<p>We issued an unqualified conclusion on the Authority's arrangements to secure value for money (VFM conclusion) for 2014/15 on 28 September 2015. This means we are satisfied that the Authority had proper arrangements for securing financial resilience and challenging how it secures economy, efficiency and effectiveness.</p> <p>To arrive at our conclusion we looked at the Authority's financial governance, financial planning and financial control processes, as well as the arrangements for prioritising resources and improving efficiency and productivity.</p>
Audit opinion	<p>We issued an unqualified opinion on the Authority's financial statements on 28 September 2015. This means that we believe the financial statements give a true and fair view of the financial position of the Authority and of its expenditure and income for the year.</p>
Financial statements audit	<p>We identified one key financial statements audit risk in our 2014/15 External Audit Plan issued in February 2015.</p> <ul style="list-style-type: none"> The Authority commissioned a full revaluation exercise on land and buildings (both HRA and General fund) as at 1 April 2014. Given the materiality in value and the judgement involved in determining the carrying amounts of assets as at the balance sheet date we considered this to be a significant audit risk for 2014/15. <p>There are no matters of any significance arising as a result of our audit work in this key risk area.</p> <p>The Authority has good processes in place for the production of the accounts. Officers dealt efficiently with audit queries and the audit process was completed within the planned timescales.</p> <p>Our audit identified one material audit adjustment. The impact of this adjustment is to increase short term investments, and decrease cash and cash equivalents, by £2 million.</p> <p>In addition, the Authority made a small number of non-trivial adjustments, most of which were of a presentational nature. There was no impact on the General Fund balance.</p>
Annual Governance Statement	<p>We reviewed your <i>Annual Governance Statement</i> and concluded that it was consistent with our understanding of your arrangements.</p>
Whole of Government Accounts	<p>The Authority prepares a consolidation pack to support the production of Whole of Government Accounts by HM Treasury. We are not required to review your pack in detail as the Authority falls below the threshold where an audit is required. As required by the guidance we have confirmed this with the National Audit Office.</p>
Certificate	<p>We issued our certificate on 28 September 2015. The certificate confirms that we have concluded the audit for 2014/15 in accordance with the requirements of the <i>Audit Commission Act 1998</i> and the <i>Audit Commission's Code of Audit Practice</i>.</p>
Audit fee	<p>Our fee for 2014/15 was £73,290 excluding VAT. Further detail is contained in Appendix 2.</p>

Appendix 1: Summary of reports issued

This appendix summarises the reports we issued since our last *Annual Audit Letter*.



This appendix provides information on our final fees for the 2014/15 audit.

To ensure transparency about the extent of our fee relationship with the Authority we have summarised below the outturn against the 2014/15 planned audit fee.

External audit

Our final fee for the 2014/15 audit of the Authority was £73,290, which is in line with the planned fee.

Certification of grants and returns

Under our terms of engagement with Public Sector Audit Appointments Ltd we undertake prescribed work in order to certify the Authority's housing benefit grant claim. This certification work is still ongoing. The final fee will be confirmed through our reporting on the outcome of that work in February 2016.

Other services

We did not charge any additional fees for other services.
