## **Decision under Delegated Powers**

#### Officer Making the Decision

#### Recommendation

That the sum of £71,277.01 of Section 106 monies that has been received as a contribution towards Community projects in Mountsorrel or Rothley be paid to Mountsorrel Parish Council for new play provision at Halstead Road/Cufflins Park, Mountsorrel.

#### Reason

To enable Section 106 monies that have been received for the enhancement of community facilities at Halstead Road/Cufflins Park in Mountsorrel to be spent.

#### Authority for Decision

Authority to pay over Section 106 monies in respect of non-housing items received by the Borough Council as the responsible authority, but which will not result in expenditure by the Council and where the Head of Service has been determined to be the relevant Head of Service by the Head of Finance and Property Services. (item 8 of the delegations to Heads of Service in section 8.3 of the Constitution)

(For the Head of Service to approve the release of funds they must be satisfied that the works to be carried out fulfil the requirements set out in the S106 agreement and have written confirmation from the relevant body that the monies will be used for their intended purpose).

## Background

Under the provisions of the Corporate Plan to 2020 - 24, there is a commitment to ensure that a growth in homes and infrastructure benefits residents through improved services and facilities.

Planning agreements negotiated with developers and land owners under Section 106 of the Town and Country Planning Act 1990 (as amended) provide a vehicle for the delivery of contributions towards infrastructure, facilities and amenities which should be:

- Necessary to make the development acceptable in planning terms
- Directly related to the development
- Fairly and reasonable related in scale and kind to the development

## Detail

Within Mountsorrel there are a number of Section 106 agreements that have been negotiated, with contributions for community facilities, children's play, open space, youth and adult recreation.

Mountsorrel Parish Council have been working on several schemes to improve community and recreational facilities within the village, including the provision of additional children and young peoples play facilities to meet an identified local need.

New facilities at Halstead Road Park, will create opportunities for imaginative and inclusive play. Equipment will meet the needs of children aged 3-7 along with some provision for older children. The area will be accessible and include infrastructure for parents to encourage family recreation.

There has been significant growth of family housing in Mountsorrel in recent years. This project responds to this growth and will improve children's play provision in a location that meets demand and addresses local priorities. The project has been identified as a priority in the Parish Councils Strategic Plan, based on local consultation and community engagement.

Mountsorrel Parish Council has consulted on the proposed play area and there is good community support for the project. Ward Councillors have been consulted and are supportive.

The project compliments wider improvements planned for Halstead Road Park and adjoining network of open space, creating a community sports and recreation hub with accessible facilities for all ages. The planned improvements will benefit the health and well-being of residents, helping to create quality open space, fostering a sense of local pride and building community cohesion. The provision of affordable community facilities will increase life chances, helping to tackle inactivity and reduce obesity particularly amongst children and young people.

The total cost of the project is £160,380.88. Section 106 funding of £51,686.58 towards the project was approved under Delegated Decision DD113 2023.

A further £71,277.01 of Section 106 funding (P/14/0058/2 & P/16/1183/2) will now be paid to Mountsorrel Parish Council. This will ensure the contribution

has been spent in accordance with the spend deadline and terms of the Section 106 Agreement.

Works have been completed and invoices submitted. The Parish Council will pay the balance of £37,417.29 from its own reserves towards the project.

Mountsorrel Parish Council has provided information in relation to this project including s106 proforma, funding and the management arrangements for the facilities.
