- 2. To ensure appropriate financial agreement is in place to complete funding transfer.

Background

In November 2020 Charnwood Borough Council was invited to be a partner in a local pilot scheme focused on supporting individuals struggling with Mental Health. In January 2021 the Council was asked to help passport the monies to those VCS organisations commissioned to deliver support through a Section 256 agreement.

LLR CCG's secured funding for the City, West and East Leicestershire Clinical Commissioning Groups for the Pathfinder Framework offer to commission organisations to deliver support locally. Funding allocation was agreed totalling £19,600.90.

Financial Implications

There are no financial implications for the Council. Charnwood will receive £19,600.90. This amount will be paid to the Council to passport the agreed amounts to the organisations as shown on the funding table attached at Appendix A to deliver the services identified. No monies will be paid out until the monies have been received by the Council.

Title of Scheme: Getting help in neighbourhoods - County Pathfinder

The agreement covers:

- Leicestershire and Rutland (LLR) Clinical Commissioning Groups (CCG's) and Local Authorities (LA's) have agreed to jointly commission voluntary and community sector (VCS) support in Charnwood to support individuals with activities related to improving and maintaining mental health and well-being.
- The Charnwood Borough Council (CBC) will passport the agreed funding to the following VCS organisations through existing contractual arrangements.
 The funding will be used to provide activity to support mental health and wellbeing as part of the Getting Help in neighbourhoods pathfinder scheme;
 - Falcon Support Services
 - John Storer House
 - Loughborough Mental Well Being Cafe
- The funding will facilitate a range of activities that will offer local residents living in the Charnwood district opportunities to get support and take part in organised activity that; have a positive impact on mental health and well-being and increases access to support.

 - Leicestershire and Rutland (LLR) Clinical Commissioning Groups (CCG's) and Local Authorities (LA's) have agreed to jointly commission locality based support for individuals living in the Charnwood district via Charnwood Borough Council who will passport agreed funding to organisations who they commission to deliver local health and well-being support and interventions.
 - The activities delivered by the VCS organisations will be a range of those agreed in the Pathfinder Framework of Offers, which has been agreed by the LLR Mental Health Collaborative system group.
