Decision and Date

Background

Under the provisions of the Corporate Plan to 2016 - 20, there is a commitment to make Charnwood an attractive place for all through funding community groups / organisations and providing a range of diverse opportunities and events.

Detail

Cabinet at its meeting on the 16th January 2020 (Min 68.) approved that up to £90,928, for Year 1 and 2, be awarded to Charnwood Citizens Advice Bureau and that the Head of Neighbourhood Services be given delegated authority to finalise the terms and conditions of the Strategic Partner Grants awarded and Service Level

Agreements and agree a final grant award amount with Charnwood Citizens Advice Bureau, in consultation with the Lead Member.

The Lead Member has been consulted and is in agreement with the recommendation.

Financial Implications

The budget for the Strategic Partner Grant Scheme for 2020/21 will be £295,400 subject to budget approval, which includes for an amalgamation of the Strategic Partner and the Specialist Money Management and Debt Advice grant budgets. There is currently a potential shortfall of £1800 in 2021/22 which will be resolved as part of the 2021/22 budget setting process.

The amounts awarded to CAB are within the available budget and take into consideration the shortfall in 2021/22.
