Recommendation

To approve the Environmental Health fees and charges for 2024/25.


Reason

To undertake the annual review of fees and charges for the services provided.

Authority for Decision

By virtue of the Delegation to Heads of Service in section 8 of the Constitution, Heads of Service are delegated to undertake the periodic review of fees and charges raised within their service areas and falling within the scope of the Council's Income and Charging Policy Framework.

Decision and Date



Background

An annual review is undertaken to consider the fees and charges made by the Council for both the statutory and discretionary services it provides. The Council has powers to charge for statutory services in specific legislation which is stated by each fee/charge below.

The Council also has the power under the Local Government Act 2003 to charge for discretionary services, in this decision marked (D), but this power is limited to recovering the costs of providing the service. Section 93(3) of the Act places a duty on the Council "to secure that, taking one financial year with another, the income from charges ... does not exceed the costs of provision".

The review of all Environmental Health fees and charges takes into consideration inflation, increases in direct costs and the charges made by other local authorities for the same service across the County.

The current inflation levels are high, and as a result the Environmental Health charges have significantly increased, to be more representative of the actual costs of providing.

Our domestic rodent pest control services charges have increased this year, but are still subsidised for residents to encourage them to use our services and free for those on specified income related benefits. This is to allow us to continue providing good value and allow people to continue to access the service to deal with public health pests.

There is a new charge for new animal activity licences only. This is because we give more time to new applicants providing advice and assistance, that needs to be included in the application fee.

All other charges are representative of the calculated cost to provide the service or in relation to enforcement to ensure consistency across Leicestershire.

The Environmental Health fees and charges for 2024/25 from 1st April 2024 are set out below:-

SINGLE ANIMAL ACTIVITY LICENCE FEE - NEW APPLICATIONS

From 1st April 2024, there will be a separate charge for new applications. This charge is £55 greater for an application fee. The licence fee is the same as a renewal application.

Additional Fees

* There is a requirement for a veterinary inspection on the granting and renewal of a hiring out of horses licence which the operator will be invoiced separately following the visit.

** For a 2-year hiring out of horses' licence there will also be an additional charge for the veterinary inspection that needs to be carried out at 12 months.

*** For a 3-year hiring out of horses' licence there will also be two additional charges for the veterinary inspections that need to be carried out at 12 and 24 months.

**** There is also a requirement for a veterinary inspection on the granting of a new breeding dogs' licence which the operator will be invoiced separately following the visit.

Additional Notes

Payment for chargeable services must be paid prior to or at time of treatment unless being recharged to landlord, formal order received, or contract agreed.

Charnwood Borough Council tenants pay the charges above unless an official order is received from Charnwood Borough Council.

If we are unable to carry out the treatment, then a £25 visit charge will remain and the service user will be refunded any remaining amount for the treatment. If they are in receipt of specified benefits then this visit charge will be reduced to £12.50 for a chargeable service and they will be refunded any remaining amount. This refund is for non-treatment only, not if the treatment is carried out and is not successful.

With the Health and Safety and business Engagement Manager having discretion to waive charges in exceptional circumstances or where a household is still experiencing problems due to the act or emission of someone else which is being investigated.
