Background

The authority for approving fees and charges has been delegated to the Director of Housing and Well Being. The proposed fees and charges detailed in the report have been put forward having taken into consideration the Council's Income and Charging Policy.

Fees and charges were last increased in April and September 2023. It is proposed to increase charges in line with CPI of 6.7% (rounded).

The Lead Member has been consulted and is in agreement with the increase in fees.

Financial Implications

The additional income expected as a result of the price increases (subject to classes being at full capacity) is estimated to cover the cost of both the venue hire and fitness instructor fees. Despite the price increases, Charnwood Borough Council still provides good value for money.

The following Sport and Active Recreation fees and charges are proposed for implementation from the 1^{st of} April 2024.
