## Decision under Delegated Powers

## Officer Making the Decision

Head of Neighbourhood Services

## Recommendation

That the sum of $£ 7,200$ of section 106 monies that has been received as a contribution towards the provision of youth / adult recreation is paid to Wymeswold Parish Council to provide an artificial cricket wicket at Burton Lane Playing Fields.

## Reason

To enable section 106 monies that has been received for the provision of children's / youth recreation and children's play in Wymeswold to be spent.

## Authority for Decision

Authority to pay over Section106 monies in respect of non-housing items received by the Borough Council as the responsible authority, but which will not result in expenditure by the Council and where the Head of Service has been determined to be the relevant Head of Service by the Head of Finance and Property Services. (item 8 of the delegations to Heads of Service in section 8.3 of the Constitution)
(For the Head of Service to approve the release of funds they must be satisfied that the works to be carried out fulfil the requirements set out in the $S$ 106 agreement and have written confirmation from the relevant body that the monies will be used for their intended purpose).

## Decision and Date



## Background

Under the provisions of the Corporate Strategy 2020-24, there is a commitment to ensure that a growth in homes and infrastructure benefits residents through improved community facilities.

Planning agreements negotiated with developers and land owners under Section 106 of the Town and Country Planning Act 1990 (as amended) provide a vehicle for the delivery of contributions towards infrastructure, facilities and amenities which should be:

- Necessary to make the development acceptable in planning terms
- Directly related to the development
- Fairly and reasonable related in scale and kind to the development


## Detail

Within Wymeswold there is a section 106 agreements that has been negotiated with a contribution for Youth and Adult Recreation.

Wymeswold Parish Council has been working with the local community to look at what additional provision is required locally and have undertaken a range of consultation. The Parish Council have identified the need for additional community youth/adult recreational facilities to enable local residents to take part in a range of activities.

Wymeswold Parish Council have been working with the local cricket club to look at options for enhancing their facilities. The need for a new batting cage and artificial cricket wicket have been identified and the club have been out for a range of quotes for various options.

Three quotes have been obtained and the cost of the proposed quote is $£ 7,200$ for the artificial cricket wicket. It is proposed to install the artificial cricket wicket at the Cricket Club at Burton Lane Playing Fields, which is leased by the Parish Council from the Wymeswold Parochial Charities who have given landlords consent and have also confirmed that the lease has been extended until 2045. The Cricket Club have self funded the provision of the batting cage to go over the artificial wicket.

Planning have confirmed that planning permission is not required and copies of the proposed scheme and quotes have also been provided.

Officers are satisfied that the scheme meets the criteria for the use of the section 106 monies. The money will not be released to the Wymeswold Parish Council until appropriate invoices have been received to ensure verification that the money has been spent.

Wymeswold Parish Council have provided information in relation to this project including design drawings, evidence of security of tenure and associated costings.
