

## Decision under Delegated Powers

### Recommendation

To authorise the release of £532.08 received in respect of a section 106 agreement attached to planning permission P/12/2569/2

The money will be paid to NHS England in order to fund works to improve the facilities at Quorn Medical Practice in Quorn.

### Reason

The release of this funding is in accordance with the relevant clauses in the section 106 agreement attached to planning permission P/12/2569/2

### Authority for Decision

There is a delegation in the Constitution to all Head of Service "to pay over section 106 Monies in respect of non-housing items received by the Borough Council as the responsible authority, but which will not result in expenditure by the Council and where the Head of Service by the Head of Finance and Property Services" (Item 8 on Page 8-15)

For all Head of Service to approve the release of funds they must be satisfied that the works carried out fulfil the requirement as set out in the section 106 agreement and have written confirmation for the relevant body that the monies are used for their intended purpose. Any unspent monies after 5 years of receipt by the Borough Council shall be returned to the developer as per the relevant clause within the section 106 agreement.

### Background

At the request of NHS England (and its predecessors), Charnwood Borough Council has been holding funds received for Section 106 healthcare contributions.

As part of the Section 106 agreement attached to P/12/2569/2, Charnwood Borough Council received £6,444.68 (subject to indexation) as a contribution towards improving the healthcare facilities at the Quorn Medical Practice in Quorn. Quorn Medical Practice requested £2,334.00 for equipment in financial year 18/19 attached to DD092.

A second business case was received from Quorn Medical Practice for improvements to two rooms within the practice to bring them upto CQC standards allowing the rooms to be used as treatment rooms for wound care and dressings. Quorn Medical Practice requested £3,357.12 (including VAT).

A further business case has been received from Quorn Medical Practice for Surgery Medical Supplies; a downstairs consultation room has been transformed into a 'hot room' due to the closure of external 'hot hubs' for use between 5pm-6pm. The area can be used by the practice nurses for dressing once the area is fitted with CQC complaint stainless steel trolleys. The requirements of the business case are for 1 single Sunflower Dressing Trolley costing £407.46 including Vat and 1 Sunflower Single Drawer Unit costing £124.62 including VAT.
