Background

The role of the Housing Allocations Team includes the assessment and determination of applications for social housing and the allocation of available social housing properties within Charnwood, including council and registered provider properties.

The Housing Allocations and Lettings Team consists of the following posts:

- 1 x FTE permanent M237 Housing Allocations Team Leaver
- 0.7 x FTE permanent H379 Housing Allocations Officer
- 2 x FTE permanent M385 Lettings Officers
- 2.4 x FTE permanent M160 Assistant Housing Officer
- 2 x FTE temporary M160 Assistant Housing Officer posts (grant funded up to 31st March 2022).

Due to increased pressures on the Housing Allocations Team and the wider Housing Needs Team associated with the COVID-19 pandemic, there is a backlog of Housing Register application assessments.

A temporary increase in hours on the M160 Assistant Housing Officer post will support the team to address these backlogs. This will support the achievement of the wider aims of the Housing Needs service, including minimizing relet times and void rent loss, making the best use of available social housing stock and preventing and relieving homelessness.
