#### Officer Making the Decision

#### Recommendation

To delete the post of Housing Projects Officer M373 (S02) and one Strategic and Private Sector Housing Administration Officer (B) M378, 37hrs post.

To increase the hours of the Housing Policy and Projects Officer M062 (S02) from 30 to 37 hours per week.

To delete HRA Asbestos Compliance Advisor Post M383 (S02) 9.35 hrs PW.

To add to the establishment a new post of Strategic and Private Sector Housing Administration Team Leader (S01).

To approve the use the funding for the two deleted posts above to cover the associated costs of the Housing Policy and Projects Officer and the Strategic and Private Sector Housing Administration Team Leader.

#### Reason

The increase in hours for the Housing Policy and Projects Officer will assist with the recruitment to this role and provide the service with additional working hours to streamline and review the services Policies.

The introduction of the Strategic and Private Sector Housing Administration Team Leader will manage and coordinate the Strategic and Private Sector Housing Administration Officers to provide a range of support services to ensure the smooth running of operational activities.

# **Authority for Decision**

The Constitution gives the Chief Executive, as head of paid service, delegated authority to agree changes to the establishment, within budget and without major operational disruption or interruption of services or involving a change from direct to indirect provision or vice-versa or other policy implications.

### **Decision and Date**

Approved 30<sup>th</sup> November 2021

#### Background

With the retirement of the existing potholder for the Housing Projects Officer, a part time role of 2 days per week a review of the team has been undertaken. With the recent difficulties in recruiting to the Housing Policy and Projects Officer a post of 30 hours the decision has been made to use one of the days from the Housing Project Officer's role to increase this to 37 hours per week.

The remaining day will be used to cover the difference in costs between the Strategic and Private Sector Housing Administration Officer and the Strategic and Private Sector Housing Administration Team Leader.

The Strategic and Private Sector Housing Administration Team Leader will manage and co-ordinate the remaining Strategic and Private Sector Housing Administration Officers to provide operational support and administration activities for the service.

The Strategic and Private Sector Housing Administration Team Leader has been through the evaluation process and the post was evaluated as S01.
