# Officer Making the Decision

### Recommendation

That the appended Order appointing the following individuals:

Catherine Duffy (Borough Councillor for East Goscote) Eric Vardy (Borough Councillor for Syston West) Ken Jones (Borough Councillor for Sileby)

as temporary Members of East Goscote Parish Council under s91 of the Local Government Act 1972, with effect from the date the Order is sealed, be made.

#### Reason

To make temporary appointments to East Goscote Parish Council to allow it to be able to form a quorum and continue to act.

# **Authority for Decision**

Section 8.2 of the Constitution gives delegated authority to the Chief Executive to undertake other election duties not reserved by the Council. Section 91 of the Local Government Act is classed as an election function, and it has not been specifically reserved to the Council.

Background

A formal request was been received from the Vice Chair of East Goscote Parish Council on 20<sup>th</sup> November 2014 for the Borough Council to intervene, as they are now unable to act following the recent resignations of several of their Councillors, which means the Parish Council cannot form a quorum and is therefore unable to make any decisions.

In such situations s91 of the Local Government Act 1972 allows the Borough Council to make temporary appointments of persons to act as Parish Councillors.

The Chief Executive has consulted with Group Leaders, and the approach which has been followed in identifying persons to be appointed has been to ask the following persons whether they would be willing to be appointed:

- 1. The Borough Councillor whose ward East Goscote falls within
- 2. The County Councillor whose division East Goscote falls within
- 3. Borough Councillors from neighbouring wards (Queniborough, Wreake Villages, Sileby, and Syston).

The persons appointed will act until 11<sup>th</sup> May 2015 (being the date on which new councillors elected on 7<sup>th</sup> May would come into office), or until such time as any by-elections to fill casual vacancies return the number of parish councillors to a level where a quorum could be established. It is anticipated that the arrangements will permit a 'care-taker' situation, allowing basic parish council business to continue for the interim period. Such arrangements would not-prevent the Parish-Council from co-opting additional members, providing the appropriate rules are followed, and one or more of the persons appointed by the Borough Council resigning from the Parish Council if a quorum was established through co-option.

Two copies of the completed Order must be sent to the Secretary of State.
