OVER 7.5 TONNES TEMPORARY NO LOADING AT ANY TIME AND

TEMPORARY IMPOSITION OF TAXI RANK) ORDER 2018

WHEREAS the Leicestershire County Council (hereinafter referred to as "the Council") being the Traffic Authority for Various Roads in Loughborough is satisfied that traffic in the said roads should be restricted to facilitate the holding and watching of events whilst reducing disruption to traffic caused by the relevant events.

NOW, THEREFORE, the Council in exercise of the powers conferred by Section 16A of the Road Traffic Regulation Act ("the act") as inserted by Section 1(1) of the Road Traffic Regulation (Special Events) Act 1984 and of all other enabling powers hereby makes the following Order:-

The first date on which this Order shall affect any of the roads given in the Schedules to this Order is 1st October 2018 and the Order may be cited as "THE LEICESTERSHIRE COUNTY COUNCIL (VARIOUS ROADS, LOUGHBOROUGH, SHEPSHED AND HATHERN) (TEMPORARY PROHIBITION OF THROUGH TRAFFIC EXCEPT FOR EMERGENCY VEHICLES, TEMPORARY NO WAITING AND LOADING AT ANY TIME,

TEMPORARY SUSPENSION OF ONE-WAY SYSTEM, TEMPORARY PROHIBITION OF RIGHT-TURN, TEMPORARY PROHIBITION OF HEAVY COMMERCIAL VEHICLES OVER 7.5 TONNES TEMPORARY NO LOADING AT ANY TIME AND TEMPORARY IMPOSITION OF TAXI RANK ORDER 2018”.

1. For the duration of the events no person shall cause or permit any vehicle to proceed along those lengths of roads and on those dates specified in Schedule 1 to this Order except for emergency service vehicles.
2. The provisions of Article 2 of this Order shall not have the effect of preventing access for more than eight hours in any period of twenty-four hours for vehicles of any class to premises situated on or adjacent to the roads mentioned in Schedule 1 or to any other premises accessible for such vehicles from and only from the said roads.
3. For the duration of the events any existing waiting restrictions imposed on those lengths of roads and on those dates as specified in Schedule 2 to this Order are hereby temporarily suspended for the duration of the events.
4. For the duration of the events no person shall, except upon the direction or with the permission of a Police Officer or a Civil Enforcement Officer, cause or permit any vehicle to wait or load on the sides of roads specified in Schedule 2 to this Order on the dates as specified in Schedule 2 with the exception of fairground vehicles with a permit and emergency service vehicles.
5. For the duration of the events the one-way traffic system will be temporarily suspended on the roads and on those dates as specified in Schedule 3 to this Order.
6. For the duration of the events no person shall cause or permit any vehicle to turn right from Southfield Road onto Bedford Square and on those dates as specified in Schedule 4 to this Order.

7. For the duration of the events no person shall cause or permit any heavy commercial vehicle over 7.5 tonnes to proceed along the roads and on those dates as specified in Schedule 5 to this Order, except for emergency service vehicles and fairground vehicles.
8. For the duration of the events no person shall, except upon the direction or with the permission of a Police Officer or a Civil Enforcement Officer, cause or permit any vehicle to load on the sides of roads specified in Schedule 6 to this Order on the dates as specified in the said Schedule.
9. No person shall cause or permit any vehicle to proceed on the length of road specified on column 1 of Schedule 7 to this Order in a direction other than that specified in column 2 of the said Schedule.
10. No person shall cause or permit any vehicle to turn left proceeding on that length of road specified in Schedule 8 to this order.
11. The prohibitions and restrictions imposed by this Order shall be in addition to and not in derogation from any restriction or requirement imposed by any regulations made or having effect as if made under the Act or by or under any other enactment.
