

# LOCAL GOVERNMENT AND PUBLIC INVOLVEMENT IN HEALTH ACT 2007

## The Charnwood Borough Council (Reorganisation of Community Governance) (Newtown Linford and Thurcaston and Cropston) Order 2018

*Made 31<sup>st</sup> July 2018*

*Coming into force in accordance with article 1(2)*

Charnwood Borough Council (“the council”), in accordance with section 82 of the Local Government and Public Involvement in Health Act 2007 (“the 2007 Act”), has undertaken a community governance review and made recommendations dated 22 January 2018:

The council has decided to give effect to those recommendations and, in accordance with section 93 of the 2007 Act, has consulted with the local government electors and other interested persons and has had regard to the need to secure that community governance reflects the identities and interests of the community and is effective and convenient:

The council, in accordance with section 100 of the 2007 Act, has had regard to guidance issued under that section:

The council makes the following Order in exercise of the powers conferred by section 86 of the 2007 Act.

### **Citation and commencement**

1. (1) This Order may be cited as the Charnwood Borough Council (Reorganisation of Community Governance) (Newtown Linford and Thurcaston and Cropston) Order 2018.

(2) Subject to paragraph (3) below, this Order comes into force on 1st April 2019.

(3) For the purposes of:

- (a) this article, and
- (b) proceedings preliminary or relating to the election of parish councillors for the parish councils for the parishes of Newtown Linford and Thurcaston and Cropston to be held on the ordinary day of election of councillors in 2019,

this Order shall come into force on the day after that on which it is made.

### **Interpretation**

2. In this Order—

“borough” means the borough of Charnwood;

“existing” means existing on the date this Order is made;

“map” means the map marked “Proposed boundary change at Newtown Linford/Thurcaston & Cropston” and deposited in accordance with section 96(4) of the 2007 Act: and any reference to a numbered sheet is a reference to the sheet of the map which bears that

number;

“ordinary day of election of councillors” has the meaning given by section 37 of the Representation of the People Act 1983; and

“registration officer” means an officer appointed for the purpose of, and in accordance with, section 8(c) of the Representation of the People Act 1983.

### **Effect of Order**

3. This Order has effect subject to any agreement under section 99 (agreements about incidental matters) of the Local Government and Public Involvement in Health Act 2007 relevant to any provision of this Order.

### **Alteration of a parish areas**

4. The area, comprising the area marked A and highlighted yellow on the map, shall cease to be a part of the parish of Thurstaston and Cropston and shall become part of the parish of Newtown Linford.

### **Electoral register**

5. The registration officer for the borough shall make such rearrangement of, or adaptation of, the register of local government electors as may be necessary for the purposes of, and in consequence of, this Order.

### **Order date**

6. 1 April 2019 is the order date for the purposes of the Local Government (Parishes and Parish Councils) (England) Regulations 2008

*(This note is not part of the Order)*

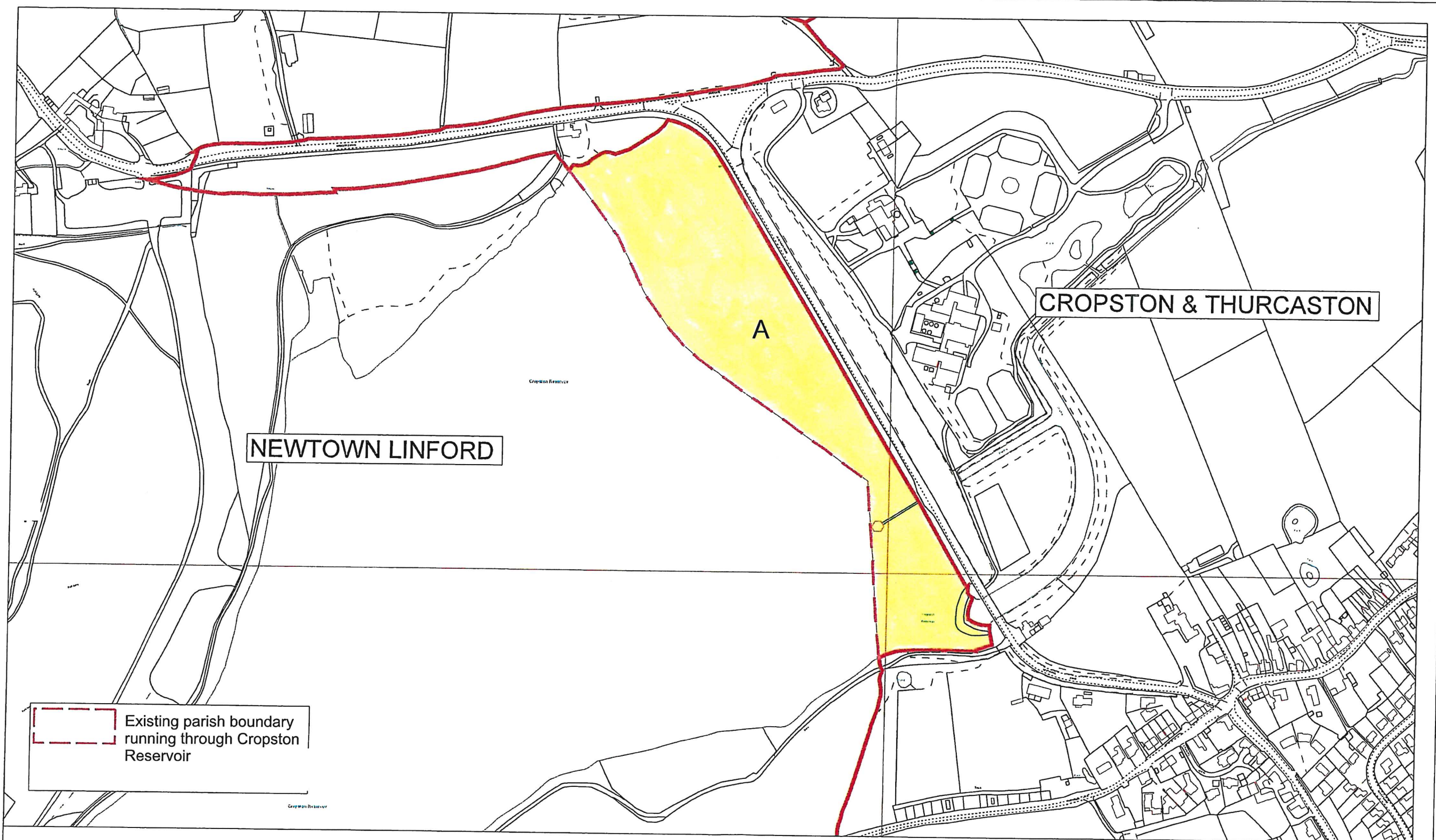
This Order gives effect to recommendations made by Charnwood Borough Council for the alteration of the boundaries of the parishes of Newtown Linford and Thurcaston and Cropston within the borough of Charnwood.
