Any beneficial interest in securities of a body where:</b> <b>(a) that body has a place of business or land in the Council's area; and</b> <b>(b) either:</b> <b>(i) the total nominal value of the securities exceeds £25,000 or one hundredth of the total issued share capital of that body; or</b> <b>(ii) if the share capital of that body is of more than one class, the total nominal value of the shares of any one class in which the relevant person has a beneficial interest exceeds one hundredth of the total issued share capital of that class</b>
