You must also include people or bodies who provide premises that relate to your official duties, such as somewhere to hold a ward surgery, at a reduced rate or other similar payments in kind.

You do not need to declare the amounts of any payments, only the name of the person or body making them. You do not need to include payments made by the Borough Council or any other local authority.

You must register all current or prospective contracts, of which you are aware, between you or your partner, or a company of which you or your partner are a director or partner, or in which you know you or your partner have a substantial beneficial interest and the Council. If in doubt, consult your financial advisor.

You do not need to show the extent of the interest.

A beneficial interest in a type of share exists if you own it or if it is held in the name of another person, e.g. a relative or partner, and you are entitled to the proceeds of, or if you will become entitled to the proceeds of, that type of share.
