  - (a) the landlord is the Council; and
  - (b) the tenant is a body in which I or a relevant person has a beneficial interest

You must register any tenancies which you, or your partner or one of your or your partner's corporate interests (see 7 below) have where the Council is the landlord. A beneficial interest in a type of share exists if you own it or if it is held in the name of another person, e.g. a relative or partner, and you are entitled to the proceeds of, or if you will become entitled to the proceeds of, that type of share.




